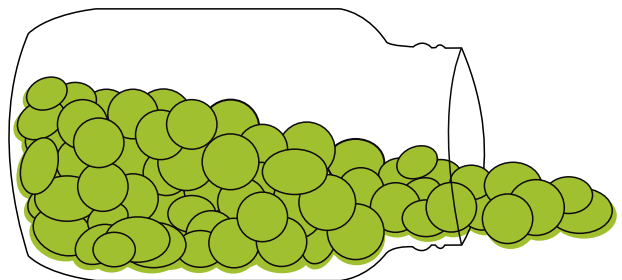
## GIFT AID IT

## HOW YOUR SUPPORT CAN MAKE A DIFFERENCE

**Use this shopping list to set your fundraising target and see the difference you will make. You can help save lives.**
